This position oversees the general supervision of program participants, program and facility operations, and transportation needs.

**QUALIFICATIONS:**

- Must be at least twenty-one years of age.
- Trained to recognize the symptoms and signs of substance abuse and to respond to drug overdose and provide documentation used to meet this requirement within 30 calendar days of hire.
- Must have proof of a state certification in substance abuse counseling and one year of professional experience counseling recovering addicts in a program that is licensed by the State of California, Department of Health Care Services.
- Experience or knowledge with evidence based practices including but not limited to Cognitive Behavioral Therapy (CBT), Motivational Interviewing (MI) and ASAM Modules.
- Not currently on probation or parole. Must be discharged for at least three years.
- Ability to work well in a team environment.
- Effective communication skills including good speaking and writing.
- Attention to detail; ability to exercise good judgment and discretion.
- Basic computer skills required with Microsoft Office applications.
- Knowledge of chemical dependency, substance abuse, personality dynamics of the substance abuser, and trauma informed/gender responsive treatment.
- Valid California Driver's License and Identification required.
- Proof of personal auto insurance may be required if position requires driving.
- Must be able to pass a criminal history background screening (Live-scan), as well as maintain a current First Aid/CPR Certification, physical exam, and Tuberculosis test results.
